STEP 1: Select your member type

Builder Member **\$599 annual dues**

Individuals or companies constructing or remodeling homes, developing light commercial projects, or developing land. All builder members are required to pay quarterly assessment fees to the HBA (you will be invoiced at \$30 per new home permit) or contribute an equal amount to the Home Building Industry Advancement Fund. This member type is eligible to receive one free HBA council membership, a \$75-\$95 value (Advanced Building Systems & Technology, Custom Home Builders, Professional Women in Building, Remodelers, or Sales & Marketing).

Associate Member **\$549 annual dues**

Individuals or companies that manufacture or provide products and services for members of the home building industry.

If your employer is already an HBA member you are eligible for the following categories:

Multi-Member **\$419 annual dues**

Discounted membership for employees of current builder or associate members. This member type is eligible to serve as a director on the HBA Board, will receive all local and national mailings, and will be listed in the HBA's annual *Membership Directory & Buyer's Guide*.

Affiliate Member **\$229 annual dues**

For employees of current builder or associate members for the sole purpose of receiving local and national mailings. Will be listed in the HBA's annual *Membership Directory & Buyer's Guide*.
