

## HBA of St. Louis and Eastern Missouri 2017 Membership Campaign

### **Member Eligibility:**

No purchase necessary to be eligible to enter. Winners must be a current HBA of St. Louis and Eastern Missouri member in good standing at time of drawing. "Good standing" is defined as having no outstanding financial responsibility owed to the HBA of St. Louis and Eastern Missouri. Winners must be at least 21 years of age at time of drawing.

### **Entries:**

Each new and complete HBA membership application for each current member in good standing will equal one entry into the drawing. An eligible entry is one in which the HBA of St. Louis and Eastern Missouri membership application is complete and is accompanied with full payment for the membership type reflected on the application. The "Sponsor" and "Sponsor's Company" in Step 8 of the application must contain the name of the current member seeking entry into the drawing upon receipt of the membership application by HBA staff. If said information is not contained upon receipt, the membership application will be processed and assigned a sponsor who will NOT receive credit for the new member and will NOT be entered into the drawing. Complete HBA membership applications received between March 1-31, 2017 and September 1-30, 2017 will qualify for double entries into the drawing. Additionally, current members will earn double entries when complete membership applications are received May 1-31, 2017 but only if those member applications are for a new Builder member, Builder Multi member or Builder Affiliate member. Current members will earn double entries when complete membership applications are received July 1-31, 2017 but only if those member applications are for a new Associate member, Associate Multi member or Associate Affiliate member. Applications for council memberships are excluded from the membership campaign. Odds of winning are based upon the number of entries received. Members having multiple entries have the opportunity to win multiple times.

### **Campaign Period:**

The campaign will commence March 1, 2017 and conclude September 30, 2017. All eligible entries must be received no later than 4 p.m. CST on September 30, 2017.
