The content in this course was developed by the EPA and HUD to properly train all contractors to work safely in housing with lead-based paint in order to comply with the EPA's Renovation, Repair and Painting (RRP) Rule and HUD's Lead Safe Housing Rule. Successful completion of this course meets the EPA training criteria for individuals that went into effect in April, 2010. Courses are approved for purposes of certification under Section 402 of TSCA for the respective discipline.

ALL paid renovators/contractors who work in pre-1978 housing, including: renovation contractors, maintenance workers in multi-family housing, painters, plumbers and other specialty trades that disturb painted surfaces through renovation, repair or painting activities must comply with this EPA rule.
